Accident Check List

- Try to remain calm! Take a few deep breaths.
- Are you or your passengers injured? Check and seek medical assistance immediately if necessary. Use your cell phone to **call 911 (Emergency)** and ask for an ambulance if you believe you or your passengers need medical attention.
- If you are able, take pictures (preferably digital) of the damage to your car, the other car and the area of the accident. Remember your cell phone has cameral function.
- If you are blocking traffic in a dangerous place, pull off to the side of the road or into a well-lit parking lot after pictures are taken.
- Make sure your thoughts are clear before you make any statements to the police.
- Don't accept fault, even if you believe the accident may have been your fault.
- Do not contact your insurance company until you have your thoughts clear and have contacted your Lawyer.
- After the accident, record all the symptoms occurred, including pains, injured body parts, mental and physical difficulty.
- Assist the police with their official report. **Get a copy of the Police repot.**
- Seek medical and chiropractic treatment to ensure proper healing of the injury and decreases residual symptoms.
- Keep receipts and the statements of the medical treatments or other expense pertinent to the car accident in order to get reimbursed upon settlement.


